Council concerned about changes to conservation authorities

There's no question the Province's Bill 23 will have major impacts on municipalities.

King has joined other municipalities in making their concerns known to the government, as the end-of-year deadline was met.

The Bill, aimed at increasing the supply of housing in Ontario, may not achieve the intended outcomes, King staff point out. Rather, green lighting projects doesn't equate to "shovels in the ground."

King staff stressed many factors impact construction, many of which are beyond a municipality's control.

Despite these factors, King is working on modifications to Township processes, with another report coming to council early in 2023.

Bill 23 amends 10 Acts, include the Planning Act, Development Charges Act, Ontario Heritage Act, Conservation Authorities Act and Ontario Land Tribunal Act, as well as several Ontario Regulations. Further, the Ministry of Municipal Affairs and Housing (MMAH) is undertaking a

housing-focused policy review of A Place to Grow and the Provincial Policy Statement.

King has already submitted its concerns to the Province, and the latest submission focused on changes to the Conservation Authorities Act, impacting all 36 authorities in the province. The ministry is looking for one consistent method across the board.

The idea is that the integration aims to create a streamlined province-wide land use planning policy framework that enables municipalities to approve housing faster and increase housing supply by:

- Leveraging the housing-supportive policies of both policy documents.
- Removing or streamlining policies that result in duplication, delays or burns in the development of housing.
- Ensuring growth management and planning tools are available where needed to increase housing supply and support a range and mix of housing options.
- Protecting the environment, cultural heritage and public health and safety.

What Are The Proposed Changes

The Township is proposing to amend the Zoning By-laws for the Schomberg and King City Urban Areas (By-law 2017-66), the Oak Ridges Moraine Conformity By-law (By-law 2005-23), and the Countryside Area By-law (By-law 2022-053) to revise the Oak Ridges Moraine Conservation Plan Area special provisions to standardize the language between the By-laws and the Oak Ridges Moraine Conservation Plan, and to remove references to the requirement for Site Plan Approval in accordance with the amendments to the Planning Act through Bill 23.

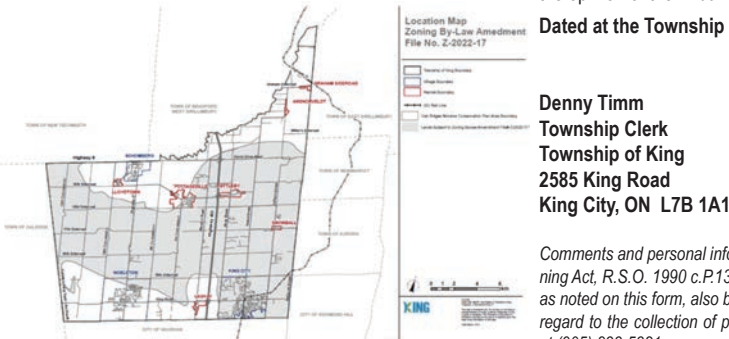

If a person or public body does not make oral submissions at a virtual public meeting, or make written submissions to the Township of King before the proposed Zoning By-law Amendments are passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal ("OLT") unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

The Township of King has received an application for a proposed amendment to Zoning By-law 74-53, as amended, and the Zoning By-law for the Countryside (2022-53) to facilitate a change of use on the property outlined below, submitted to the Township of King in accordance with Section 34 of the Planning Act, R.S.O. 1990, Chapter P.13, as amended.

PROPOSAL

The subject Application proposes to amend Zoning By-law 74-53 and the Zoning By-law for the Countryside 2022-53 to permit a greenhouse use, together with other related uses on the property including an apary. The subject property is designated "Agricultural Area", "Oak Ridges Moraine Natural Linkage Area" and "Natural Heritage System" as per the Township of King Official Plan, Our King (2019).

On September 26th, 2022, Township of King Council adopted the By-law for the Countryside (By-law 2022-53). This Zoning By-law has since been appealed to the Ontario Land Tribunal. Once all appeals are resolved, the By-law will be in effect retroactive to the date of adoption of the By-law. As such, all applications that are identified within the Countryside are to be assessed for compliance with both the old Zoning By-law (By-law 74-53, as amended) and the new Zoning By-law (By-law 2022-53). Within Zoning By-law 74-53, as amended, the property is zoned RU1 (Rural General) and ORMNCL (Oak Ridges Moraine Natural Core and Linkage). Within Zoning By-law 2022-53, the property is zoned GNH (Greenbelt Natural Heritage) and ORL (Oak Ridges Moraine Natural Core and Linkage).

The Applicant has submitted a Zoning By-law Amendment to rezone the property to a site specific zone to permit a greenhouse use, together with other related uses on the property including an apary.

The proposed development seeks to construct a greenhouse with a building area of 44,700 square metres (4.47 hectares) to be built out in three (3) phases. The greenhouse operation will consist of new smart farm agricultural technology including a hydroponic operation using automated machinery. The amendment seeks site specific zoning provisions for lot coverage and parking requirements to facilitate the development. The proposed works are further subject to approval through a Site Plan Development Application.

Until such time as a public meeting is scheduled in accordance with the Planning Act, the Township of King will provide further notice specifying the date and time of the meeting. Any person may attend the public meeting (or participate virtually if the meeting is being held remotely), and/or make written or verbal representation either in support of or in opposition to the proposed zoning by-law amendment.

However, a one-size-fits-all approach doesn't always work, staff said. "A uniform regulation does not take into consideration site-specific and area-specific considerations."

The proposed regulation would amend the Conservation Authorities Act to focus permitting decisions only for matters related to the control of flooding and other natural hazards and the protection of people and property.

Currently, there are 36 individual regulations under the Conservation Authorities Act, one for each Conservation Authority in the Province that set out the activities and associated requirements for permits or permissions. These 36 regulations are proposed to be revoked through the amendments to the Conservation Authorities Act, and in their place the Ministry is proposing a single provincial regulation to ensure clear and consistent requirements. The regulation is proposed to streamline rules

for development and increase coordination between Conservation Authority permitting and municipal planning approvals.

While staff are supportive of the Province's goal of providing additional housing, they are uncertain whether the increased residential permissions within the rural area as it may result in a loss of agricultural land. It may also place increased development pressures on rural and agricultural communities.

Staff have concerns with the Province's approach to develop a uniform offsetting policy for all of Ontario. While the offset policy is proposed to be based on five principles, including avoidance first, having a Provincial offset policy sets a precedent that an offset is appropriate in all circumstances. Further, a uniform approach and general baseline assessment "may not be appropriate for all municipalities and Conservation Authorities. A uniform approach does not take into consideration site-specific characteristics for each municipality and Conservation Authority or site-specific conservation goals."

Staff specifically request clarification if the offset policy is proposed to only be used within urban areas and settlement areas, or if the offset policy is proposed to apply to all lands across Ontario, including within the Greenbelt Plan and Oak Ridges Moraine Conservation Plan areas.

Five principles identified in the Discussion Paper detail that limitations on offsetting would only be placed where the key natural heritage feature has historically been important for recreation and/or tourism. This does not take into consideration features that have important ecological considerations and as such severely limits what features would be eligible for protection.

The Discussion Paper, staff noted, is also unclear as to the administrative and implementation of the offset policy. The Discussion Paper notes that there is an opportunity for the compensation payment to be applied to a larger project outside of the watershed or in a different geographic area. Based on this proposal, it is unclear as to how the compensation amounts would be determined; how the payments are proposed to be collected; and whether this system would be administered by the Conservation Authority, Municipality or Province. Further, it is unclear who would be approving the offsetting plan for a proposed development, and whether this would fall under the jurisdiction of the municipality, or if it would become a Provincial responsibility.

As such, staff recommend that the offsetting policy not proceed as currently contemplated in the Province's Discussion Paper. The proposed policy would result in negative impacts to key natural heritage features, and the lack of clarity for its administration may result in delays in its implementation, as well as the potential for it to be implemented inconsistently.

"Should the Province wish to proceed with a policy relating to offsetting, staff recommend that the Province require each Conservation Authority and municipality develop their own offset policy that responds to their area-specific requirements, rather than the Province developing a one size fits all approach."

Staff stressed there are still many unknowns and the Province has to be clearer on certain directions.

Staff is asking the Province to provide sufficient time to municipalities, stakeholders, and the public to review and provide comment the proposed Plan.



History and tradition contained in the Mayor's Chain of Office

The accoutrements of municipal government are steeped in history and tradition.

There's a certain amount of regalia and there's no better example in King than the Mayor's Chain of Office. Worn on special occasions and during council meetings, this chain tells the story of King.

Starting at the left shoulder, the first medallion honours the Welsh and English pioneers of the area with the leek and the rose.

The second medallion recognizes the large equestrian interest in the community.

The plates which follow are inscribed with the names of the five communities now incorporated into the Township - Laskay, Snowball, Ansnorveldt, Kettleby and Schomberg.

The next medallion on the left is the

flower of Ontario, the Trillium.

The large pendant bears the crest of the "new" Township of King. The crest features a plate depicting a crown for "King," a sheaf of wheat, hills and rivers, and a beaver, symbolizing the various activities of the area.

Continuing up the right side, the first medallion is the Trillium, and then the Ontario Coat of Arms surrounded by maple leaves.

Corresponding with the left side are the names of the five remaining communities (making a total of 10) also incorporated into the Township - Nobleton, Lloydtown, Strange, Pottageville and King City.

The next medallion honours agriculture and consists of a corn stalk, pumpkin and pear.

The last medallion on the right side again honours our pioneers this time the Irish and Scottish, with a shamrock and thistle.

Mailboxes vandalized

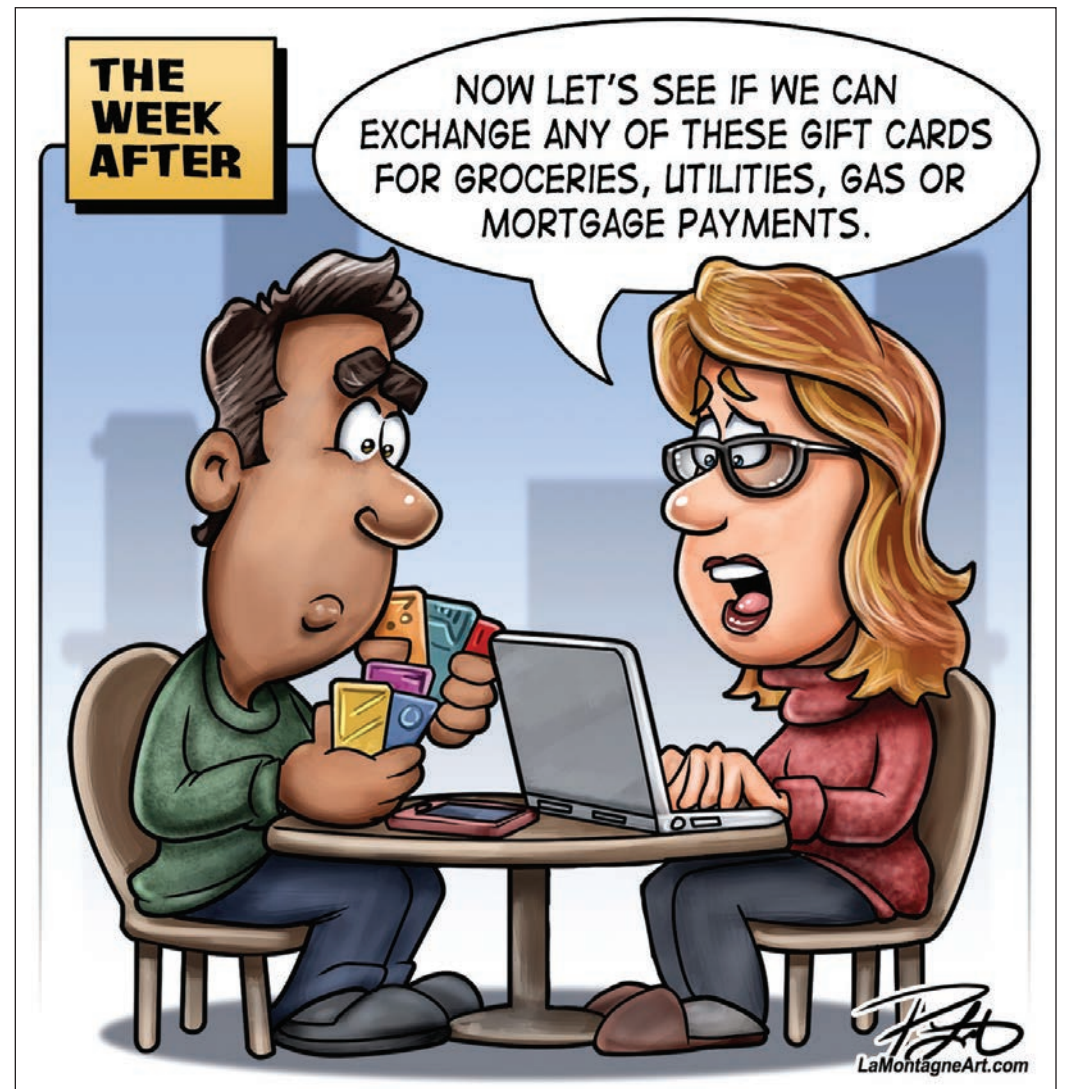
We came to get our mail on Nov. 26 and found that our mailbox had been vandalized with all the doors ripped open and our mail gone.

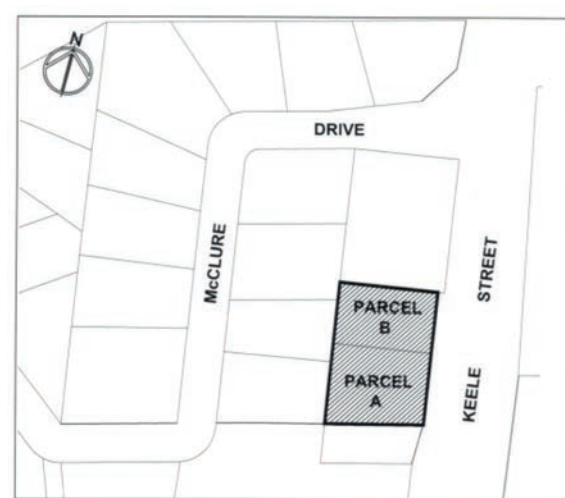

New home in King turns out to be a perfect fit

No, King City is not a sovereign land reserved for Kings and Queens, despite how the name implies a society where residents' pinkies are permanently held high. It's laid back and rural. A place where you feel comfortable enough to walk outside without a full face of makeup on or your Sunday best crisp white blouse.

I've called King City my home for the last two years. But it never interested me to live in a place where nature overshadows tall sky towers. This was until I saw the trees that border King Road after you pass the "Welcome to King City" sign. They colour my world no matter the season and I'd hug them if there weren't so many neighbours around raking leaves and walking their dogs.

My parents' decision to fulfill a lifetime dream of building a bungalow saw our family relocate here. But adjusting to a smaller, more rural area after living in a larger urban one was difficult.

My initial thoughts weren't pleasant. But to be fair, the tape wrapped around the tree bark of all our neighbours' trees was straight out of a horror film. Apparently, this was to keep pests from eating away at them, but just thinking about it makes my skin itchy.

Then, I discovered that our front yards are invaded every year from June to August by gypsy moths that resemble caterpillars and spiders with more legs than I can count. It made me want to hide in my basement, but unfortunately, more creatures live there.

I initially thought visitors were un-

welcome because the locals wave at the same people jogging every morning. Though, putting your hand up and waving "hello" is polite in King, whether you know them or not. If you don't glance up or nod your head, the locals assume you're not feeling well or being rude.

After watching the local farmers and artisans set up their foldable tables and homemade signs every weekend in early November, I started appreciating the outdoors and warmed up to what the town could offer. The natural, earthy scent of freshly picked fruits and organic veggies, together with the tiny crystal jars holding homemade jam and the vibrant dried flowers, made me rethink shopping at the grocery store ever again.

"My Nana just finished making these jams this morning. Give them a try and here, take some free lemonade!" the lady behind the stand said to me while rushing to grab a plastic cup to fill.

She eagerly waited for someone to notice her hand-crafted wooden stand and checkered tablecloth display each weekend.

Making a local neighbour's day special with a bit of extra change was all the convincing I needed to buy all three flavours of Nan's freshly made jams. Without a doubt, they were the best jams I've ever tasted, and I'd feel guilty to return to Smucker's synthetic flavours ever again.

After meeting some of my neigh-

bours at the markets each weekend, I learned that the town hosts community events like handmade wreath-making and hiking along the central East Humber trail. This favourite trail among King City residents has some of the most uncommon wildlife species in the GTA, like the Black-Billed Cuckoo and the Ring-Necked Pheasant.

They also drink wine over charcuterie boards. A favourite local producer is a winery in the Holland Marsh, Ontario's most productive agricultural area. Blocks of grapes generate year-round local premium wine grow on its 22 acres of sandy, clay-like loamy soil. The land is famously known as the "salad bowl of Ontario" because of all the vegetables it produces. As you drive past, you can smell the distinctive grassy scent of green onions, but once you arrive at the winery, it becomes the woody smell of wine casks. While you can schedule a tasting to try their wines, you can also taste them at some of the local restaurants.

Even though there aren't many options for eating out, those available are of the highest quality. The Roost Cafe, located between Kind Road and Keele Street, is set in a rustic, old house and attracts people from all over the GTA.

As soon as you turn the loose knob on the door, you instantly smell the wholesome, nutty, bitter brew of cof-

fee. Then comes the overwhelming decision: what to order from the perfectly arranged display of freshly baked goods - blueberry flax muffins or perhaps a chocolate chip cookie. Spending your pocket change here rather than at chain coffee shops like Starbucks or Tim Hortons is worth it. Mostly because you'll never see whimsical tropical wallpaper, bright yellow seating, and an outdoor balcony that looks out to braided ancient tree roots there. It's usually easy to spot when tourists visit because their outfits match the café's aesthetic. In the fall, young girls dress in plaid jackets and wide-brimmed hats. Instead, the locals throw on casual jeans and a long-sleeved shirt.

Of course, the town's quietness sometimes makes me miss the sound of sharp horns and tall sky towers.

The GO station across from the fire hall makes a thunderous rumble every few hours, but unless you live directly behind it, most residents don't seem to be bothered by it. After all, it's valuable since commuters can reach Toronto in just under an hour.

Whoever gave this city its name didn't understand its distinct character. King City should be renamed "Serendipity City." It's a quiet town where you can hear your own thoughts. Once you come to appreciate them, they can unexpectedly bring joy.

The 28-year-old OPP officer was murdered on Dec. 27, 2022 while responding to a call west of Hagersville.

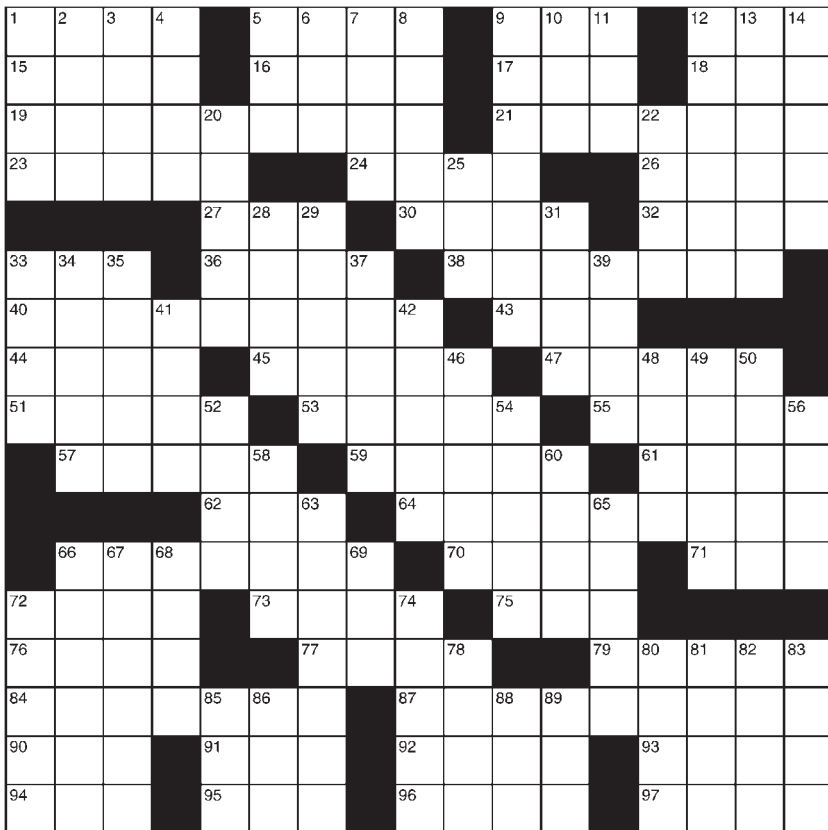
The procession travelled northbound on Highway 400 to Barrie.

Ontario sees strong growth in 2022

Ontario's property inventory continued to grow in 2022, with more than \$37.8 billion in new assessments, which includes new construction and improvements to existing properties. Residential homes made up over \$28.6 billion of the increase, while commercial and industrial properties comprised of \$4.6 billion.

The assessed value of Ontario's 5.5 million properties is now estimated to be more than \$3.08 trillion. MPAC summarizes these changes in the annual assessment rolls that they delivered to Ontario's municipalities.

Over the course of the year, Ontario added more than 48,000 residential homes. While the number of new detached homes increased 10.5% year over year (25,727, up from 23,279), the number of new residential condominiums dropped by 37.4% (7,097, down from 11,331). There was also a small increase in new townhouses, coming in at approximately 1.3% (10,484, up from 10,350).

"The slowdown we see in new residential condominiums is attributed to construction delays arising from changing economic considerations and supply issues," said Nicole McNeill, President and CAO. "Despite this slowdown in new residential condominiums, we did see year-over-year growth in other property types."

Across Ontario, more than 55% of new property value was located in 10 municipalities. Toronto led the way for another year at \$8.7 billion (down from \$10.7 billion in 2021) followed by Ottawa at \$4.4 billion (up from \$3 billion), then Mississauga at \$1.2 billion (down from \$1.6 billion), Vaughan at \$1.1 billion (down from \$2 billion), and Oakville at \$1.1 billion (holding steady) for another year.

When looking at the growth rates for small municipalities (under 15,000 population), Blue Mountains had the largest overall growth this year (\$140.2 million) despite a drop in new seasonal properties from the previous year (down to \$29.3 million from \$32.7 million). Muskoka Lakes followed with \$120.3 million, then Middlesex Centre with \$103.7 million, North Perth with \$90.9 million and Carleton Place with \$89.9 million.

Property assessments for the 2023 property tax year will continue to be based on Jan. 1, 2016 assessed values. This means your property assessment remains the same as it was for the 2022 tax year, unless there have been changes to your property.

MPAC is an independent, not-for-profit corporation funded by all Ontario municipalities, accountable to the Province, municipalities and property taxpayers through its 13-member Board of Directors.

Their role is to accurately assess and classify all properties in Ontario in compliance with the Assessment Act and regulations set by the Government of Ontario. They are the largest assessment jurisdiction in North America, assessing and classifying more than 5.5 million properties with an estimated total value of more than \$3 trillion.



Hortons previews new packaging and cutlery

Tim Hortons restaurants across Canada are eliminating the use of more than 90 million single-use plastics a year by introducing wooden and fibre cutlery, starting in early 2023. Plastic lids on Loaded Bowls are also being replaced by fibre lids.

A new breakfast and lunch wrapper that will also be introduced early next year features an efficient design that uses 75% less material than the prior wrap box, which is estimated to save more than 1,400 tonnes of material a year.

The test of the fibre hot beverage lid, which is plastic-free and recyclable, is now live in the City of Vancouver and will run for approximately 12 weeks.

Tim Hortons is also now trialing a fibre hot beverage lid that is plastic-free and recyclable. The goal of the trial, which will run for approximately twelve weeks in the City of Vancouver, is to develop products that are alternatives to plastic and easier to recycle and repurpose while still offering a great guest experience.

"Through our sustainability platform Tims for Good, we're always looking for ways, big and small, to make thoughtful choices on material and design in order to reduce and eliminate packaging and contribute to more sustainable innovation," said Paul Yang, Senior Director of Procurement, Sustainability and Packaging at Tim Hortons.

Tim Hortons restaurants will also eliminate the use of all single-use plastic bags and will begin offering guests reusable bags for purchase starting in January.

York University launches bursary for women pursuing STEM-related programs

The York University School of Continuing Studies announced an endowed bursary to benefit women students enrolled in Science, Technology, Engineering, or Mathematics (STEM) related programs at the School. This new bursary is funded by a \$100,000 donation from Aquicon Construction Company.

Aquicon also committed an additional \$25,000 in support of York's Emergency Student Support Fund to provide essential financial assistance for full-time York students affected by the ongoing conflict in Ukraine.

Aquicon was chosen as the general contractor for the School's stunning new building in October 2019, which broke ground on the structure in March 2020.

The School of Continuing Studies offers certificate programs that allow international students and Canadians to reskill or upskill in high-demand fields and seize new career opportunities in as little as six months of study.

A defining mandate of the School since its creation in 2015 has been to create accessible opportunities for underrepresented populations, including gender equity in a variety of male-dominated emerging technology fields.

"Looking at our student data over the last several years, we noticed several exciting trends. From fall 2019 to winter 2020, 29.1 per cent of students enrolled in the School's tech programs identified as women. In the following year, that grew to 35.4 per cent," said Tracey Taylor-O'Reilly, assistant vice-president of

continuing studies at York University.

"Across North America, we are seeing more women pursue careers in STEM-related fields, shrinking the gender gap within these industries. This bursary aims to continue this trend and offer women greater access to upskilling and reskilling opportunities in these high-demand professions. I am deeply grateful for Aquicon's generosity and commitment to the pursuit of education, and I am so excited for this bursary to help women learners pursue exciting new career paths."

Taking cybersecurity as an example of this trend, when the School launched the country's first university-level cybersecurity certificate program in 2017, approximately 10 per cent of the industry identified as female. But in recent years, those numbers have increased. According to a 2020 report by (ISC)², women currently account for 25 per cent of the global cybersecurity workforce.

The first of these bursaries will be awarded in 2029. Find out more about professional programs offered at the School.

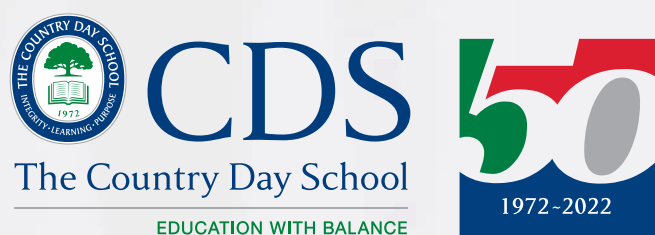

When Ontario Provincial Police (OPP) officers come across a child who has been involved in a stressful or traumatic situation, giving them an OPP Community Bear can help them regain a sense of calmness and security.

Community Bears aren't just soft and cuddly, studies have shown that kids who spend a lot of time holding a stuffed animal tend to feel calmer and more secure, and that teddy bears can even help children cope with psychological trauma.

Thanks to a new partnership with the Ontario Provincial Police Association (OPPA) Credit Union, these bears will continue to be made available in communities across Ontario. 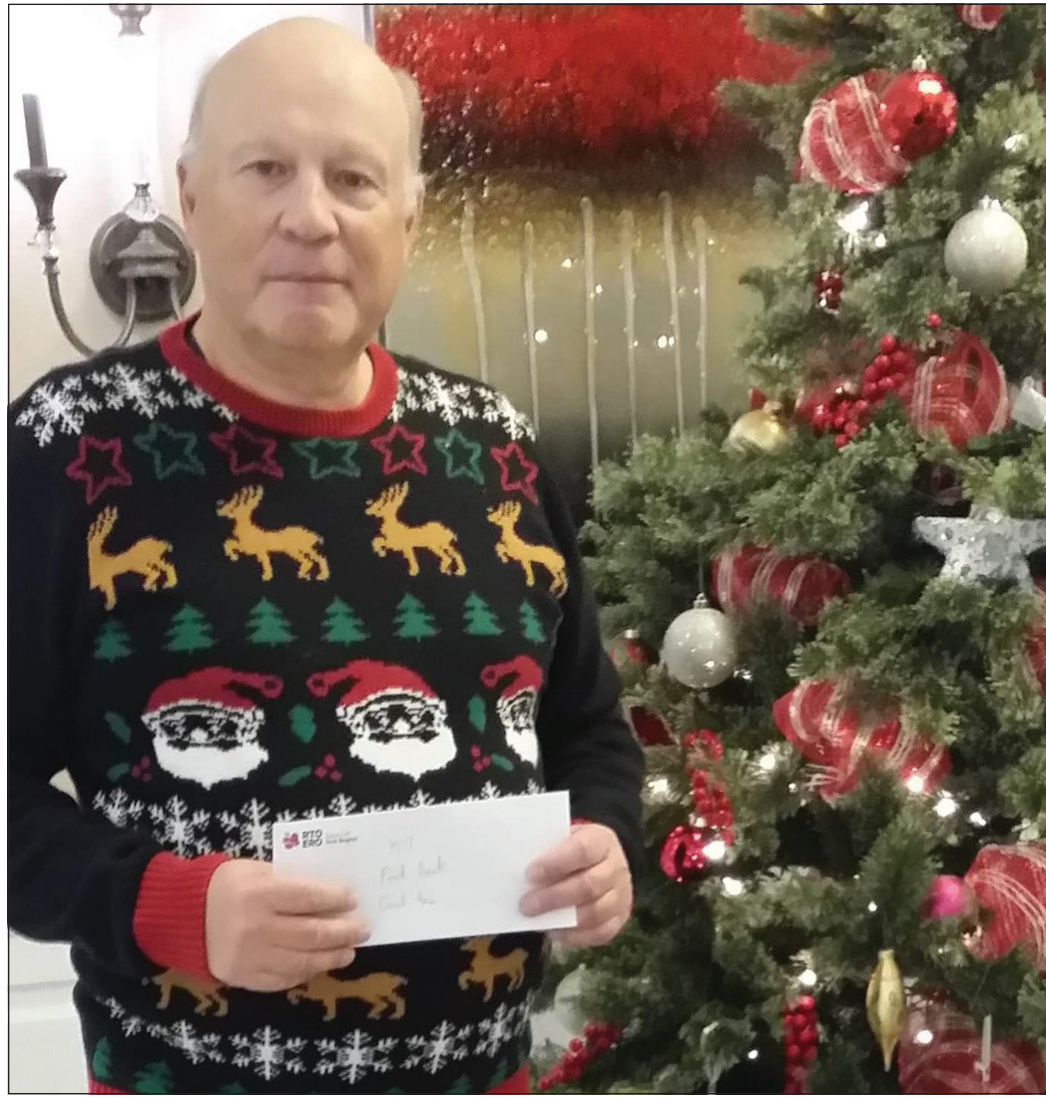

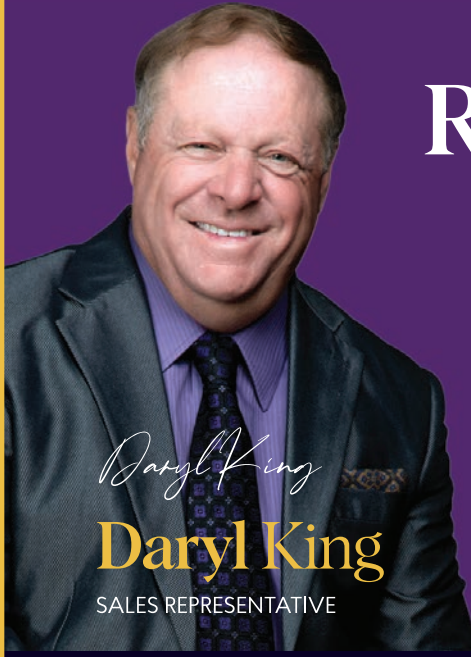

Police seize 200 vehicles worth \$17 million

Investigators with the York Regional Police Auto/Cargo Theft Unit, working with partnering agencies, laid multiple charges against organized vehicle theft groups and have recovered more than 200 stolen vehicles worth \$17 million in an ongoing vehicle theft investigation dubbed Project Touchdown.

Over the past several years, York Regional Police and partner agencies have seen an increase in thefts of vehicles and we have increased efforts to combat this issue.

Project Touchdown is a joint-forces investigation involving Peel Regional Police, the Durham Regional Police Service, the Halton Regional Police Service, the Canada Border Services Agency and Équité Association, with assistance from the CP and CN Police. Funding provided by the Government of Ontario, Criminal Intelligence Service Ontario, supported the joint investigation.

During this six-month project, officers intercepted and recovered 215 vehicles valued at approximately \$17.4 million which were being trafficked to international destinations. Fifty-one people have been arrested and more than 150 charges have been laid.
